

## **EHSA Board of Directors History**

With the formal incorporation of the Echo Hill South Association on March 21, 1969, a mechanism for electing the Officers and Directors to maintain the common lands was set in motion. The original Bylaws provided for a Board of 9 Directors to be elected for staggered terms (two for 3 years, two for 2 years, two for 1 year) by the membership at the annual meetings. The Bylaws also provided for the inclusion of four Officers: a President, Vice-President, Treasurer and Secretary to be chosen annually by a majority vote of the membership. These Officers “shall serve until his successor has been elected and qualified.” It appears that in the early years of the Association the four Officers were chosen from the ranks of the Directors, for many documents list an individual as both an Officer and Director. From the list below, it is apparent that the Association seldom had a full complement of Directors unless you count an Officer twice, e.g. once as President and once as a Director.

When the Bylaws were revised in 1992, the number of Officers and Directors was clarified along with the procedures for election. The Bylaws now read:

The affairs of the corporation shall be managed by a board of ten (10) directors who shall be Members of the Corporation. Six of the directors of the Board shall be elected by the Membership at large for terms of three years. The terms of these directors shall be staggered such that each year two (2) of the director positions shall be up for election. The President, Vice-President, Treasurer and Secretary (who are elected at the annual meeting) shall be members of the Board of Directors. [The Officers are elected annually for one-year terms].

The following list was compiled from diverse documents, particularly from the minutes of the annual meetings when available. The records for the years 1980-1984 are particularly sparse, and the list for these years may be inaccurate. It is the writer’s hope that the list is as complete and accurate as possible.
